The Community Energy Conservation (CEC) Program and Municipal Energy Manager (MEM) Program provide financial rebates to help identify energy-saving opportunities and implement Retrofit Projects, in municipally owned facilities. Through either the CEC and MEM program, municipalities can receive rebates for Energy Audits that support investment decisions and Complex Retrofit Project rebates for implementing energy efficient retrofits in their facilities.

Program Allies are professional firms with the ability to deliver Energy Audits through either the CEC or MEM programs. Program Allies can help participating municipalities identify and quantify energy-saving opportunities in their facilities that can be acted upon through a Complex Retrofit Project.
